

SonShine Learning Center programming is year round. This is a contract for the September 2, 2019 to June 12, 2020 period. Those enrolled will have priority in enrolling in the next period (September to June). While SonShine reserves the right to increase tuition rates at anytime with a thirty day notice, the rate increases are typically released in August of each year.

**Multiple Child Discount**

A 10% discount will be given to families who enroll two or more children.

**Early Drop-Off and Late Pick-Up Fees**

If you drop-off before your contracted hours or pick-up after your contracted hours, you will be assessed a \$1 per minute per child early/late fee. All children are considered signed-in while on the premises.

**Consistent Weekly Schedule**

We plan our staffing around the days and hours children are enrolled. Once you select your schedule you must commit to it without change for the remainder of the enrollment period so that we can carry out the program plan.

Should I decide to withdraw my child from SonShine Learning Center, I agree to give at least a two week notice of withdrawal. I understand that I am responsible for the full tuition during this period of notice as well as any other fees that may apply.

I agree to pay tuition in advance. Failure to do so could result in termination of SonShine Learning Center services. Tuition is due on or before the first day of the week your child attends SLC. Any weekly tuition not paid in full by Wednesday of that week may result in a \$25.00 late fee.

I understand that the business hours of SonShine Learning Center are 7:00am-5:30pm. Late pickup fees must be paid in cash upon arrival. Repeated late pick-up may result in termination of child care services.

I understand that the program hours are 8am-4:30pm. For an additional fee, children may attend between 7am-8am and 4:30pm-5:30pm.

I give permission for my child to go for walks off of the SonShine Learning Center campus around the surrounding area.
